DIRECTIONS FOR USE: Beef and Dairy Cattle: For the control of hornfly and lice apply a solution of 1 litre of Starbar Back Rubber Concentrate in 25 litres of fuel oil to the back rubber device. One device should be continuously available for each 35-45 head of cattle. Refill applicator every 2-3 weeks. Do not apply to animals under one month of age. Do not apply to adult animals nursing young. May be used up to time of slaughter.

DISPOSAL PROCEDURES: Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Conservation and Protection, Environment Canada.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful by swallowing, inhalation or skin contact. Avoid breathing spray mist. Avoid contact with skin. Wash thoroughly after handling.

Change contaminated clothing. Do not contaminate food or feed products.

FIRST AID: In case of exposure to malathion, move patient from area and remove all contaminated clothing. Wash all exposed skin with soap and water. If in eyes, flush with water. If breathing is weak or irregular, give artificial respiration. Get prompt medical attention.

TOXICOLOGY: Symptoms of poisoning include headache, weakness, sweating, giddiness, blurred vision, nausea, abdominal cramps, diarrhea and discomfort in the chest.

Atropine is antidotal: Give 2 to 4 mg. of atropine sulphate intramuscularly or intravenously immediately and every hour as required until pupils dilate.
