Directions for use:

To control thrips (exposed), aphids, red spider mites, white flies, and mealy bugs, on ivy, fuschia, rubber plant, african violet, bracken, boston fern, philodendron, gloxinia, and other similar plants. Apply as directed. Repeat as necessary. With mealy bugs, take care to wet insects thoroughly.

TO OPERATE: Put plants in suitable place for spraying. Remove cap. Direct nozzle at plants, holding dispenser 45-60 cm away from them. Depress valve to operate, using short one second bursts. Spray from all sides. Be sure to spray both surfaces of leaves. Do not overspray the plants. Do not use on moss fern, cyclamen, lantana or maidenhair fern. Do not spray plants in excessive heat, hot sun or when wet.

PRECAUTIONS: Keep out of reach of children.

Avoid breathing spray mist. Harmful if swallowed. Wash after using. Do not contaminate utensils, food, drinking water, or dishes. Remove fish bowls and bird cages from room during spraying. Do not apply to humans, pets or birds. Do not spray on plastics, asphalt tile or furniture. Do not use or store near heat or open flame. Do not puncture, contents under pressure. Store at room temperature. Exposure to high temperature may cause can to burst. Keep away from direct sunlight, radiators, stoves, hot water and other heat. Do not throw empty container into fire or incinerator.

FIRST AID: If in eyes, call a doctor immediately. If on skin, wash with plenty of water and soap.

TOXICOLOGICAL INFORMATION: High vapor concentration may cause confusion, pulmonary irritation and tremors.
