DIRECTIONS FOR USE:

Apply a minimum of two coats by brush or dip, to all cuts in pressure treated wood or wherever untreated wood is exposed. Allow time between coats for each application to sink into the

wood.

PRECAUTIONS:

Keep out of reach of children.

May be fatal if swallowed. May cause severe skin irritation, chemical burns or eye irritation. Avoid contact with skin, eyes or clothing. Wear eye protection and gloves impervious to creosote during use.

Do not carry, store, or consume food or drink in areas where creosote is stored or where freshly treated wood is stored. Do not smoke or carry cigarettes in work areas. Do not expose cuts or abrasions to creosote. Get immediate first aid if eyes contact creosote. Keep work areas well ventilated. Keep away from open flame.

When handling treated wood, wear coveralls, impervious gloves and impervious boots. Wear a respirator if treated wood is handled in enclosed areas.

USE PROTECTIVE CLOTHING MADE FROM THE FOLLOWING MATERIALS: Viton, neoprene, butyl rubber, nitrile, polyvinyl chloride, polyvinyl acetate.

FIRST AID:

If swallowed, call a doctor. If on skin, wash immediately with soap and water. If in eyes, flush with clean water. If irritation persists, obtain medical attention.

Eye Contact: Immediately flush eyes with flowing water, occasionally lifting the upper and lower lids. Continue flushing for at least 15 minutes. If irritation develops, get prompt medical attention.

Skin contact: Immediately remove soaked clothing or articles in contact with the skin. Remove from skin with degrease hand cleaner. Wash contaminated skin with soap or mild detergent and water. If irritation develops, get prompt medical attention.

Inhalation: Immediately move the exposed person to fresh air. Apply artificial respiration if breathing has stopped. Keep the affected person warm and quiet. Get immediate medical attention.

Ingestion: Provided that victim is conscious, induce vomiting using syrup of ipecac. Get immediate medical attention.

TOXICOLOGICAL INFORMATION:

Contains mainly aromatic hydrocarbons.

Effects of acute exposure: Fumes are irritating to skin, eyes, and respiratory tract. Photo sensitization can occur following skin contact.

Ingestion: May result in sweating tremor or convulsions, curculatory collapse and respiratory failure.

Effects of chronic exposure: Prolonged and repeated exposure may lead to dermatitis and, in isolated cases when used with poor industrial hygiene practices, has been reported to cause skin cancer.
