DIRECTIONS: Use a sprayer which produces a fine mist.

FOR FLYING INSECTS: Close doors and windows. Remove pets.
Cover fish bowls. Spray freely towards ceiling until room is
fogged with mist. Keep sprayer at least 60 cm from walls and

furniture. Keep room closed 10 minutes.

FOR CRAWLING INSECTS: Spray directly on as many insects as possible. Spray must contact the insects in order to give control. Cockroaches, ants, silverfish: spray along baseboards, into cracks and crevices etc., where these pests hide. Repeat as necessary. Bedbugs: spray baseboards, floorboards, springs and mattresses. Take beds apart and spray all joints. Moths, Carpet beetles: spray closets or containers thoroughly reaching all crevices.

Spray woollen articles especially seams and folds. Repeat application every 30 days unless treated articles are immediately stored in moth tight containers. Spray infested carpets thoroughly. Fleas: spray floors, floor coverings and sleeping quarters of pets. Repeat as required.

PRECAUTIONS: Combustible mixture. Keep away from children. Do not use or store near open flame. Do not smoke while spraying. Avoid contamination of foods, dishes and utensils. Do not spray on plastics or mastic asphalt tile. Avoid inhalation. Do not incinerate or burn container. Do not use on humans, pets or plants.
