#### DIRECTIONS FOR USE

Prior to the use of 1722 in water cooling towers, systems should be cleaned to remove algal growth, microbiological slime, and other deposits. Then make an initial slug addition of 250 to 490 mL of 1722 per 10,000 litres of water in the system. Repeat initial dosage until control is evident. Make subsequent slug additions of 80 to 490 mL of 1722 per 10,000 litres of water every 1 to 5 days or as needed. The frequency of addition depends upon the relative amount of bleedoff and the microbiological problem. Slug additions should be made in the sump of water cooling towers.

#### PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Workmen handling the product should avoid contact of the product with clothing or skin. After any exposure, wash promptly and thoroughly with an abrasive soap and cool water and finally with glycerin. Keep the drum closed when not in use. Do not reuse container. Destroy when empty.

FIRST AID AND TOXICOLOGY: If swallowed, call a physician immediately. Give patient doses of powdered charcoal immediately or all he can swallow of raw egg whites, milk, gruel, or flour and water. Then induce vomiting. In case of persistent irritation of the skin, obtain medical attention. If the product gets into the eyes, flood eyes immediately and thoroughly with cool water for 15- 30 minutes. See a physician if any irritation persists.
