AGRICULTURAL:

Formulated with Pyrethrins, Piperonyl Butoxide and Diatomaceous Earth.

When used as directed, this product can be used as a dust coating of all construction surfaces in poultry houses, hog houses and dairy barns, where cows are milked. This product will eliminate flies, cockroaches, silverfishes and gnats.

DIRECTIONS:

Do not use as a general space spray. Avoid breathing the dust, use a suitable dust mask and allow adequate ventilation. Using any good hand duster, lightly dust the interior part of the poultry house, hog house and milk barn. Remove animals before

treatment. Treat before milking starts or after milking is finished. Direct dust into cracks, crevices and other hiding places. When possible hit insects directly with dust. Repeat as necessary.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid inhalation of spray. Avoid contact with skin, eyes and clothing. Wash after use. Do not remain in treated areas. Ensure proper ventilation during treatment. Wear a suitable dust mask. Unprotected persons should not enter the area during application or subsequent clean-up. Do not contaminate feed or water troughs. Do not spray over milk or milking equipment. Cover milk and milking utensils to prevent contamination from spray and dead insects. Any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before re-use. Do not use in areas where bee-keeping equipment or supplies are stored. Product toxic to fish. Do not contaminate any body of water.

DISPOSAL:

Do not reuse container. Empty container completely by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Dispose of empty container in accordance with provincial requirements. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use and dispose in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills contact the regional office of Conservation and Protection, Environment Canada.
