DIRECTIONS FOR USE: To be used only in the manufacture of a herbicide which is registered under the **Pest Control Products Act**. Read Technical Bulletin for formulation details.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND/OR UNAUTHORISED PERSONNEL. Harmful if swallowed. May cause skin and eye irritation. Avoid contact with skin, eyes or clothing. Wear protective goggles and gloves when handling. Wash hands and exposed skin thoroughly after handling.
