**DIRECTIONS FOR USE:** Wilson Pruning Paste is formulated to protect newly-cut or damaged surfaces of trunks and branches from disease and decay, to help prevent loss of sap and to guard against entry of wood-boring insects. Wilson Pruning Paste is unharmed by freezing weather and may be used year-round.

**TREE WOUNDS:** Prepare surface by removing all dead or diseased portions of wood or bark. Trim rough edges of wound with a sharp knife. Old infected wounds should be sterilized with a solution of 25 grams copper sulphate (bluestone) mixed in 1 litre of water. Apply Pruning Paste with a stiff brush, trowel or putty knife. Large cavities should be thoroughly cleaned out and sterilized with copper sulphate solution, filled with concrete and when set, heavily coated with Pruning Paste.

**PRUNING CUTS:** Make pruning cuts close to main limb or trunk. Do not leave stumps. Use sufficient material to completely cover the wound areas and exclude all air. If sap causes Pruning Paste to blister, puncture to release sap, then press back in place and seal puncture. Thinning should not be necessary but if desired or for cleanup, use varsol or a paint thinner.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Harmful if swallowed. Keep away from open flame or sparks.

**FIRST AID:** This product contains petroleum distillate. **If swallowed,** DO NOT induce vomiting. Contact a poison control centre and get medical attention IMMEDIATELY. **If on skin,** wash thoroughly with soap and water. **If in eyes,** flush immediately with plenty of water for at least 15 minutes. **If inhaled,** move patient to fresh air and obtain medical attention. Take container, label or product name and P.C.P. Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse container. Wrap in newspaper and dispose of empty container with household garbage.
