Hold can 90 cm from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes, and all surfaces of upholstered furniture. Avoid wetting furniture and carpeting. Do not use as a space spray. Do not spray wood surfaces, as water spotting may occur. A fine mist applied uniformly is all that is necessary to kill fleas and ticks. Retreat as necessary. Be sure to treat pet bedding and other resting places, as these are primary hiding places for fleas and ticks. No need to remove pet bedding after treatment. DO NOT USE ON PETS. PRECAUTIONARY STATEMENTS: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed or inhaled. Avoid contact with skin, eyes or clothing. Wash thoroughly after using. When used in the house, all food processing surfaces and utensils should be covered during treatment. Cover exposed food. Do not apply while processing, preparation, or serving is underway.
