Certified Lab Products' CERTAMATE is an effective residual insecticide which provides rapid kill of the insects listed hereon including those resistant to certain chlorinated hydrocarbon and organo-phosphate insecticides. The product stays on the treated surface and kills insects weeks after the spray deposit has dried.

**RESTRICTIONS:** Do not apply to rugs, carpets, draperies,

wallpaper or similar materials that may be stained. DO NOT USE AS A SPACE SPRAY.

**INDOOR APPLICATION:** For ants, cockroaches, crickets, silverfish, saw toothed grain beetles - mix 1 part of Certified Lab Products' CERTAMATE to 9 parts of water. Spray the mixture into cracks, crevices, around baseboard and other places where these insects hide. Apply beneath cabinets, refrigerators, sinks, stoves and in and around waste containers. For ants, spray trails and places where ants enter.

**BUILDINGS - OUTDOOR SURFACES:** For houseflies - mix 1 part of Certified Lab Products' CERTAMATE to 9 parts of water. Apply at the rate of 1 litre of this mixture to 12 square metres or to runoff.

Ants, clover mites, crickets, earwigs, fleas, millipedes, mosquitoes, sow bugs and brown dog ticks: treat infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios or other places where insects may enter. For ants, treat hills and runways. Repeat when necessary. Do not spray vegetation.

**Brown Dog Ticks:** Mix 1 part of Certified Lab Products' CERTAMATE to 9 parts of water. Spray sleeping quarters of pets around baseboards, window and door frames, wall cracks and local areas of floor. Repeat when necessary. Fresh bedding should be placed in animal quarters after spraying. Do not treat animals.

**PRECAUTIONS IN USE:** May be fatal if swallowed, inhaled or absorbed through the skin. Avoid breathing the spray mist and provide adequate ventilation of areas being sprayed. Wash hands, arms, and face with soap and water after handling and before eating or smoking. Wash all contaminated clothing with soap and water before reuse. Do not get in eyes, on skin or clothing. In case of prolonged exposure, wear rubber gloves, protective clothing and goggles. Wash thoroughly after using. Avoid contamination of food, utensils and food preparation areas. Do not allow children to contact treated areas until surfaces are completely dry.

**FIRST AID:** In case of contact wash thoroughly with soap and water. If swallowed, drink one or two glasses of water and induce vomiting by touching back of throat with finger or other blunt object. Get prompt medical attention.

**TOXICOLOGICAL INFORMATION:** Should illness occur, get prompt medical attention. Atropine sulphate is antidotal. This product contains petroleum distillate as a solvent.

**NOTE:** This product is toxic to fish and wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams or ponds.
