DIRECTIONS FOR USE

This product is for use only with an injection tube and for injecting into cracks and crevices where insects may be hiding, living and breeding. Place injector tip 2 cm into cracks, crevices, holes and other small openings where insects may be a

problem. Release approximately 1 second spray per spot. In serious infestations, if possible, place spots approximately 30 cm. In light infestation or preventive treatment place spots approximately 1 m apart. See the additional directions below for effective control of specified insects. Food Handling Establishments: Limit to crack and device treatment only. Apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where insects hide.

CRAWLING INSECTS: Centipedes, Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders, and Ticks: Spray into hiding places such as cracks and crevices, moist areas, openings around pipes and sinks, behind baseboards, metre boxes and manholes. Spray directly on insects in these locations where possible

Booklice & Silverfish: Spray cracks and crevices in baseboards, door frames, bookcases and storage areas. Spray directly on insects in these locations where possible.

Ants: Spray into trails, nests and points of entry around doors, windows, structural cracks and crevices. Spray directly on insects in these locations where possible.

Drug Store Beetles (in exposed adult and larval stages). Flour Beetles, Grain Weevils, Moths and hibernating stages of: Boxelder Bugs, Clover Mites, Cluster Flies and Elmleaf Beetles. Contact as many insects as possible when treating infested areas such as cracks and crevices, in wall voids, around window and door frames, under siding, in machinery and in dark secluded areas.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with eyes, skin, clothing and avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking, etc. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact. Hospitals: Do not use in nurseries or rooms where infants, ill or aged persons are confined. CONTENTS UNDER PRESSURE. Do not puncture or incinerate container. Do not store or use near heat or open flame. Exposure to temperature above 50 degrees C may cause bursting. Do not spray on plastic, painted or varnished surfaces or directly onto any electronic equipment such as radios, televisions, computers, etc. Precautionary statements for food handling/processing plants: Avoid contamination of food or food processing surfaces. In food processing plants use only when plant is NOT in operation. Remove or cover all food, food processing equipment, packaging materials and utensils before application. After application wash all surfaces that may contact food and rinse with potable water before re-use for food

processing.

STORAGE: Keep product in cool and dry place, away from open flames and heat sources.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Dispose of empty container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.

FIRST AID INSTRUCTIONS: Product contains petroleum distillate. If swallowed, do not induce vomiting and seek medical attention at once or poison control centre at once. In case of contact with eyes or skin, flush with water. If irritation persists, seek medical attention.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. Obtain medical attention immediately, taking the pesticide container with you.
