**Usage**

For daily damp sanitizing of private hospital, nursing homes, use 12ml per litre (200ppm) of water.

For heavy duty cleaning and disinfecting and fungicidal activity against pathogenic fungi, use 25ml per litre for best results. Use Bacticlean with a cloth or mop and apply to walls, floors and other hard surfaces.

If used for sanitization of food contact items, limit the level to 200 ppm of quaternary (250ml per 20 litres). Rinse with clean potable water.

For floor stripping and extra heavy cleaning use 50ml Bacticlean per litre of water. Do not mix with soap or anionic solutions.

Bacticlean is non-corrosive in use dilutions on inanimate hard surfaces. Bacticlean works immediately, safe on floors, walls, woodwork, equipment - all washable surfaces. Effective in soft or hard water and BACTICLEAN has a pleasant odor.
