DIRECTIONS: Place baits in locations where rats and mice feed, water and / or travel. Bait placements along walls, in corners and in concealed locations where rats and mice can feed unobserved are desirable. Contaminated or spoiled baits would be replaced promptly. Treated baits should be placed in location not accessible to children, pets, wildlife and domestic animals or in tamper proof bait boxes.

FOR NORWAY RATS (*Rattus norvegicus*) and Roof rats (*Rattus rattus*): Each station should contain at least one packet of bait. Maintain constant supply of bait for at least 10 days.

FOR HOUSE MICE (*Mus musculus*): Open the pack and place 15 g (tablespoon amounts) of bait at 2 to 3 metre intervals. An uninterrupted supply should be maintained for at least 15 days.

PRECAUTIONS: Keep away from humans, domestic animals and pets. Keep away from feed and foodstuffs. May be harmful or fatal if swallowed or absorbed through skin because this material may reduce the clotting ability of blood and cause bleeding. This product should be handled with gloves. Keep out of lakes, streams and ponds.

DISPOSAL: Dispose of unused stale bait and empty packs in accordance with local requirements.
