Hagen Carpet Guard instantly starts to kill Fleas and Brown Dog Ticks. It also kills silverfish and carpet beetles. Hagen Carpet Guards contains residuals, formulated for effective spot treatment of carpets and broadloom. Spray contaminated areas as needed. It may be necessary to repeat treatment within 1 to 2 weeks if reinfestation occurs.

DIRECTIONS FOR USE: FOR SPOT TREATMENT: Shake well before using. Hold bottle in upright position 25-30 cm away from surface being treated. Test small area of carpet for color fastness before full application. Spray surface until thoroughly wet. Spot treat in areas where pests are most likely to be present. Treatment must only be repeated if pest problem reoccurs. Treat your pet with Hagen flea and tick products registered for use on pets before allowing them into the treated areas. **DO NOT TREAT PETS WITH THIS PRODUCT.** For effective flea and tick control, the pet should be treated with a registered flea and tick control product designed for use on pets, and treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas prior to treatment with this product. **THIS PRODUCT IS NOT TO BE USED DIRECTLY ON PETS. KEEP PETS AND CHILDREN AWAY FROM TREATED AREAS UNTIL ALL SURFACES ARE DRY.**

PRECAUTIONS: PHYSICAL & CHEMICAL HAZARDS: Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. Keep away from open flames or sparks. **HUMANS: KEEP OUT OF REACH OF CHILDREN.** Avoid inhalation of vapors, contact with skin or eyes. Harmful if swallowed. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Wear rubber gloves during application of this product. **DO NOT USE ON HUMANS, ANIMALS, FOODSTUFF, FOOD UTENSILS, PLANTS, FISH BOWLS OR ANIMAL FEED. NEVER USE AS A SPACE SPRAY. In home or other dwellings, remove or cover all food or cooking utensils before treatment of an area. Thoroughly wash any surface that may come in contact with food after applications of spray. FIRST AID: HUMANS: If sprayed in eyes, flush with clear water for 15 minutes and seek medical attention. If sprayed on skin, wash immediately with soap and water. If accidentally swallowed, obtain medical attention at once or call a Poison Control Centre. Do not induce vomiting. **PETS:** Sensitivities may occur after using ANY pesticide for pets. If signs of sensitivity occur, bathe the pet with mild soap and rise with large amounts of water. If signs continue, consult a veterinarian immediately. Take container, label or product name and P.C.P. Number with you when seeking medical or veterinary attention.

TOXICOLOGICAL INFORMATION: Contains volatile petroleum distillate. Treat symptomatically.

DISPOSAL: When container is empty, wrap and discard in garbage. Do not puncture or incinerate.
