DIRECTIONS:

VAPONA FOGGING SOLUTION is a ready-to-use insecticide for the control of mosquitoes, flies, gnats and other annoying insect pests. Vapona Fogging Solution is specifically formulated for use in thermal and mechanical fogging apparatus but not for units activated by steam pressure.

Fogging Outdoor Areas: Apply 7 to 14 litres Vapona Fogging Solution per hectare or approximately 75 to 150 millilitres per 100 square metres. For best results thoroughly fog insect breeding and resting areas such as bushes and other heavy foliage, window sills, garbage cans, etc. Apply when the air is calm (late evening or early morning) when there are few wind currents and when wind currents are not rising. Repeat treatment as necessary.

Farm Buildings: (Dairy barns, horse barns, shelter sheds and milk sheds). Apply 200 millilitres of Vapona Fogging Solution per 100 cubic metres of enclosed space. Before applying reduce air movement as much as possible by

closing windows, doors and other openings, and remove all animals from buildings. Do not apply in milk rooms or milk processing rooms. Repeat treatment as necessary.

Empty Grain Storage: To control the exposed stages of common pests in stored grain such as saw-toothed grain beetle, red flour beetle, granary weevil, rusty grain beetle, foreign grain beetle and meal moth apply 200 millilitres of Vapona Fogging Solution per 100 cubic metres of enclosed space. It is generally desirable to make the application in the late afternoon in order that the storage may be closed all night; thoroughly ventilate before reentry.

CAUTION:
