Cross-contamination is of major housekeeping concern not only in hospitals, but in Schools, institutions, and industry. LONZA FORMULATION R-82-54 has been formulated to aid in the reduction

of cross-contamination in these areas.

LONZA FORMULATION R-82-54 is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal, fungicidal and will prevent the growth of mold and mildew and their odors when used as directed.

LONZA FORMULATION R-82-54 is an effective one-step sanitizer-cleaner for use on non-food contact surfaces.

When used as directed, LONZA FORMULATION R-82-54 will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas and other places where bacterial growth can cause malodors.

DIRECTIONS FOR USE:

LONZA FORMULATION R-82-54 is a proven "on-step" disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply LONZA FORMULATION R-82-54 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, or mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION: To disinfect hard, non-porous surfaces, add 4 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level, LONZA FORMULATION R-82-54 is also virucidal, fungicidal.

SANITIZING: To sanitize non-porous, non-food contact surfaces, add 1 mL/L of water. Treated surfaces must remain wet for 60 seconds.

4 mL/L Use-Level: The broad spectrum activity of LONZA FORMULATION R-82-54 has been evaluated and found to be effective against the following organisms by the AOAC Use-Dilution test :

AOAC Fungicidal Test: LONZA FORMULATION R-82-54 is an effective fungicide against Trichophyton Mentagrophytes (the athlete's foot)

fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc.

Mold and Mildew Control: at 4 mL/L LONZA FORMULATION R-82-54 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general cleaning instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance: at 4 mL/L use-level, LONZA FORMULATION R-82-54 was evaluated and found to be effective against the Influenza A/Brazil Virus on inanimate environmental surfaces. At 16 mL/L it is effective against Adenovirus, Type 5.

Sanitizing: Non-Food Contact Surfaces (such as floors, walls, tables, etc.) at 1 mL/L use-level, LONZA FORMULATION R-82-54 is an effective sanitizer against Staphylococcus aureus and Klebsiella pneumoniae on hard non-porous environmental surfaces.

Instructions for Cleaning and Decontaminating Against HIV-1 on Surfaces and Objects Soiled with Blood or Bodily Fluids:

This product is effective against HIV-1 (Human Immunodeficiency Virus) in hard water up to 400 ppm (CaCO₃), and in the presence of organic soil (5% blood serum).

Personal Protection: When handling items soiled with blood or bodily fluids, wear disposable latex gloves, gowns, masks, and eye coverings.

Cleaning Procedure: Thoroughly clean blood or bodily fluids from surfaces before applying "Formulation R-82-54".

Contact Time: To Kill HIV-1, apply "Formulation R-82-54" at 16 mL for 4 Litres of water and allow surface to remain wet for 1 minute.

Disposal of Infectious Materials: Blood, bodily fluids, cleaning materials and clothing should be autoclaved and disposed of according to provincial and local regulations for infectious waste disposal.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. DANGER - CORROSIVE TO EYES. DO NOT GET IN EYES, ON SKIN OR ON CLOTHING. HARMFUL IF SWALLOWED. AVOID CONTAMINATION OF FOOD.

FIRST-AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician or poison

control centre immediately. Take container, label or product name and Pest control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

DISPOSAL:

1. Triple or pressure rinse the empty container. Add the rinsings to treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
