SHAKE WELL BEFORE USING

This product is designed exclusively for industrial and institutional use by trained professional maintenance personnel. Label directions and precautions must be followed exactly. For use in Apartments, Condominiums and Similar Living Areas and in Non-food Areas of Kennels and Commercial Buildings such as warehouses, Theatres, Office Buildings, Schools, Motels, Hotels, Restaurants and Food Processing Facilities. GENERAL: Use this product as a spot treatment to control cockroaches, silver-fish, ticks, fleas, and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found or an infestation may occur. Spray surfaces until wet. Repeat as needed.

TO KILL COCKROACHES, ANTS, CRICKETS, SILVER-FISH, SPIDERS, AND SOWBUGS: Spray areas where these pests are found or may hide,

including dark corners or rooms and closets, cracks and crevices in walls, along base-board and door and window frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.

TO KILL BROWN DOG TICKS AND FLEAS: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices along and behind baseboards window and door frames and local areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with fresh bedding after treatment of pet area. DO NOT spray pets with this product. Treat pets with a product registered for animal application to control the source of flea infestation.

FLIES AND MOSQUITOES: Use only as an aid in reducing annoyance from these insects. Spray outside surfaces if window and door frames, as well as, other areas where these pests may enter. Also spray dark corners and localised resting areas such as under eaves, or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.
