DIRECTIONS:

Before disinfection, flush hard surfaces or objects with cold water; clean with soap or detergent solution; then rinse thoroughly with clean water. Apply R-2-L solutions by wet or damp mopping, scrubbing, pressure washing, immersion or spray-and-wipe procedures. Treated surface should remain wet with diluted R-2-L solution for at least 10 minutes.

General Disinfection: (food plants, dairies, restaurants, health

care institutions). Use 4 mL per litre of water (1:250). Food contact surfaces treated with this solution MUST be rinsed with potable water.

Critical Disinfection: (areas where Pseudomonas are suspected). Use 12 mL per litre of water (i.e. 1:80). Food contact surfaces treated with this solution MUST be rinsed with potable water.

Sanitizing Rinse: Use 2 mL per litre of water (i.e. 1:500). Food contact surfaces treated with this solution do not need to be rinsed.

SPECIAL APPLICATIONS

Deodorizing: Use 10 mL per litre of water (1:100).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Protect eyes and mucous membranes from this product. Wear rubber gloves and splash-proof glasses, goggles or face shield when handling this product or its use solutions. Avoid prolonged or repeated skin contact. Do not spray or splash onto foodstuffs. DO NOT MIX WITH ANYTHING BUT WATER. Avoid contact with oxidizing agent (i.e. hypochlorites) even in trace amounts, as mixture can be explosive.

FIRST AID:

EYES: Immediately flush with plenty of cool running water. Remove contact lenses. Continue flushing for at least 15 minutes holding eyelids apart to ensure rinsing of the entire eye.

SKIN: Immediately flush with plenty of cool running water. Wash thoroughly with soap and water.

IF SWALLOWED: DO NOT INDUCE VOMITING. Rinse mouth immediately, then drink one or two glasses of water or milk. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON. CALL A PHYSICIAN OR POISON CONTROL CENTRE IMMEDIATELY.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
