DIRECTIONS:

To Clean and Disinfect: All water washable hard, non food contact surfaces dilute 12 mL of 2005 Pine Disinfectant detergent per litre of water (1:80). Apply to surface, scrub.

To Clean and Disinfect Critical Areas: All water washable, hard, non food contact surfaces, dilute 25 mL of 2005 Pine Disinfectant

detergent per litre of water (1:40). Apply to surface, scrub.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Corrosive. Avoid contact with eyes and skin. Wear rubber gloves and splash-proof glasses, goggles or a face shield when handling concentrate. Do not contaminate food or food contact surfaces. Do not use on animals.

FIRST AID:

Eyes: Immediately flush with plenty of cool running water. Remove contact lenses. Continue flushing for at least 15 minutes holding eyelids apart to ensure rinsing of the entire eye. Consult a physician.

Skin: Immediately flush with plenty of cool running water. Wash thoroughly with soap and water.

If swallowed: Do not induce vomiting. Rinse mouth immediately, then drink one or two glasses of water or milk. Never give anything by mouth to an unconscious person. Consult a physician.
