DIRECTIONS FOR USE: Use for dry cooking onions, green bunching onions, pickling onions and spanish onions. Prepare the seed bed and shake Greenleaf Onion Maggot Granules into the furrow with the seeds, sets or transplants at the time of planting. Use 40 grams per 10 m of row. If the maggots have developed to flies (adult stage), use Greenleaf Diazinon Spray according to label directions.
