DIRECTIONS: Do not use until labels, technical manual, revisions and MSDS are read and understood. This product is to be used as a marine vessel hull coating only. Store in a cool dry place away from food, feed and ignition sources. When ready to use, warm to

at least 18 degrees C, and mix into Can A (Resin) following manual instructions. Use immediately.

PRECAUTIONS - DANGER: Eye and skin irritant. Harmful if inhaled. Wear an air-fed respirator during handling and application. Wear chemical resistant gloves, footwear and clothing with head covering at all times during handling and application. Keep out of reach of children. Handle with care and mix only in a closed container. Use only in a well ventilated area. Do not smoke, eat or drink when using. Shower immediately after work. Wear freshly laundered clothes daily. Wash hands and face before eating, drinking, smoking and using the toilet. Store and wash all protection clothing separately from household laundry.
