DIRECTIONS FOR USE:
USE ONLY IN A WELL VENTILATED AREA.

CATS AND DOGS: Remove safety cap and insert sprayer. Cover pet's eyes with hand and with a firm, fast stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips rub onto face and around mouth, nose and eyes. Then spray neck,

middle and hindquarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On longhaired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure that the spray thoroughly wets ticks. Repeat treatment as needed; do not treat more often than once per week.

PET'S SLEEPING QUARTERS: Spray around baseboards, windows, door frames, wall cracks and local area of floors. Repeat as needed. Pet's bedding should be sprayed, making sure the area beneath the bedding is sprayed too. After spray has dried, remove old bedding and replace with fresh bedding.

PRECAUTIONS HUMAN: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing of spray mist and provide adequate ventilation of treatment area. Avoid contamination of food. Wash hands with soap and water after using. Keep away from heat or open flame. Do not apply to painted or finished wood surfaces.

PETS: Do not treat kittens or puppies under 8 weeks of age. Do not treat nursing females. If pet is pregnant, or under drug or pesticide treatment, contact a veterinarian regarding proper product use.

ENVIRONMENTAL: This product is toxic to fish. Do not add directly to water. Do not apply where runoff is likely to occur. FIRST AID: If swallowed, induce vomiting. If illness should occur, see a physician. In case of eye contact, flush with plenty of water.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat and open flame. Do not contaminate water, food or feed by storage or disposal. Do not transfer contents to other containers.

DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in garbage.
