INSTRUCTIONS

LAUNDRY Dilute 40 to 50 mL of this product in 1 litre of water and pour in your wash water before adding laundry. Safe for nylon, orlon, terylene and for all fast colours. Do not use on wool, silk, unfast colours, leather or silverware.

DIFFERENT USES Removes stains, disinfects and deodorizes toilet bowls, baths, garbage cans, sick rooms, linoleum, woodwork, tiles, counter sinks, refrigerators, dish water, 15 mL per 1 litre of water.

ON THE FARM Normally: 20 mL of this product in 10 litres of water yields a solution containing 200 ppm available chlorine. The use of this product at a concentration equal or greater than 200 ppm available chlorine on materials or surfaces which come into direct contact with food should be followed by a rinse with potable water.

SWIMMING POOL Chlorination guide: use of test kit is recommended (chlorine and pH). Test pH of the water. The pH value should be maintained between 7.2 and 7.8. Add daily to maintain the level of chlorine residual from 0.6 to 1.0 ppm.

Suggested daily charge covers only average conditions. Weather and frequency of usage will affect dosage required (135 to 270 mL per 10,000 litres of water). Do not use the pool until the chlorine residual has dropped below 2.0 ppm. Never pour under direct sunlight. To purify your wading pool add daily 7 mL for every 100 litres of water.

CAUTION

Do not mix with a toilet bowl cleaner, rust remover, household ammonia or acids. Avoid contact with skin and eyes.

FIRST AID TREATMENT

If splashed in eyes or on skin, flush thoroughly with water. If swallowed, give one or two glasses of milk or warm water. Call physician immediately. Keep patient warm.
