DIRECTIONS FOR USE

Remove cap and press down plastic button with hole away from you.
Hold at a convenient distance from the animal, approximately
15cm, so that the spray penetrates to the skin. Work from the

back of the animal towards the front of the animal; fluffing the hair may help permit the spray to penetrate. Keep the spray moving constantly. Spray only enough that the hair and skin are slightly damp. Wet ticks with spray. Do not allow spray to get in eyes, or on scrotum.

For cats spray on the basis of a 4 to 6 second application for a 2.25 kg cat; for dogs spray on the basis of a 20 to 30 second application for a 11.5 kg dog. Repeat treatment, if necessary, should not be more often than once weekly. Also treat bedding, interior of kennel and other places where ticks and fleas may be found. The cool sensation caused by the spray, as well as the hissing sound, may temporarily frighten nervous pets. Pets are expected to become accustomed to this treatment.

PRECAUTION: Avoid breathing of spray mist. Do not contaminate food or water. Wash hands after use. Keep out of reach of children. Minimize treatment about the eyes and face. Avoid contact with eyes. Do not treat puppies or kittens less than 4 weeks old, nor allow them to be exposed to this product. Sensitive cats may exhibit temporary and non harmful salivation. Do not store near sources of heat. Do not throw into fire.
