DIRECTIONS: Kills flying insects in livestock housing areas including Dairy Barns, Beef Barns, Hog Barns and Milk Houses. Remove all animals from the treatment area before using as a space spray. Close all windows and doors and extinguish open flames during treatment. Apply at a rate of 15 seconds per 30 cu. m of space. Direct mist upwards in sweeping motions towards all parts of the building, especially windows and other light sources and where insects are present. When treating small areas you need to only partially depress the valve. When treating larger housing areas you may depress the valve until it

clicks and then it will be locked in an open position allowing you to remove your finger. After you have completed spraying stop the spray by pushing the valve up with your thumb. Keep room closed for 30 minutes and then ventilate treated areas thoroughly for at least 30 minutes before animal re-entry.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not remain in treated areas. Ensure proper ventilation after sealed areas have been treated. Cover milk and milking utensils to prevent contamination from spray and dead insects (Any treated surface that may contact food or feed products should be washed and rinsed thoroughly with potable water after spraying and before re-use). Do not contaminate food or water troughs. Avoid inhalation of spray. Avoid contact with skin and eyes. Wash hands and exposed skin after using. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate can or store at temperatures over 50 deg. C. Do not spray into or near any open flame.

FIRST AID: If sprayed in eyes or on skin, rinse with clean water. If irritation persists, obtain medical attention. If accidentally swallowed obtain medical attention at once.
