FOR GENERAL TREATMENT CONTROL OF: Fleas, cockroaches, ants, crickets, silverfish, firebrats, moths, flies, wasps, weevils, psocids, spiders, beetles, centipedes, mosquitoes.

DILUTION INSTRUCTIONS:

1. Shake 3M Premises Flea Spray Concentrate vigorously for 15-20 seconds before diluting.
2. Add 12 parts warm water and one part of Concentrate to your spray bottle. At this dilution, this 379 mL bottle of concentrate will provide one treatment of an area of approximately 111 sq. metres (1200 sq.ft.). For best results, we recommend the use of the one litre 3M Pump Up Sprayer.

STEPS TO EFFECTIVE FLEA CONTROL:

1. Thoroughly clean and vacuum your home. Seal the vacuum bag and dispose in the garbage.
2. Shake the diluted 3M Premises Flea Spray to disperse all the microcapsules before spraying.
3. Adjust the sprayer nozzle to give a fine mist spray. If nozzle clogging occurs, unscrew nozzle and wash under tap.
4. Spray diluted 3M Premises Flea spray on any surface that may be harbouring fleas. This includes pet resting quarters, furniture, under beds, hallways, closets, etc. Flooring, particularly carpets, should be sprayed thoroughly.

NOTE: WE RECOMMEND PATCH TESTING CARPETS AND FURNITURE ON A HIDDEN AREA AND ALLOW THESE AREAS TO DRY BEFORE APPLICATION.

5. We recommend you limit vacuuming to high traffic areas for at least 30 days. 3M Premises Flea Spray Concentrate provides residual activity for at least 30 days when applied according to label instructions.
6. Repeat application as needed.

DO NOT APPLY DIRECTLY TO PETS.
