Directions for use: For exterior use only. Château wood preservative is a highly effective, ready-to-use solution, that protects wood, tarpaulin or rope against rot, mildew and termites. Use above ground. Will not bleed through if painted over. This product also increases the life of your wood. Will not evaporate or wash out.

Coverage: Up to 9 sq. m./litre of wood, or 4 sq. m./litre of 240 g tarpaulin, or 7 kg of rope.

Apply by brush, or dip: Apply as much solution as will readily soak up. The effectiveness of the preservative is determined by the penetration, so apply liberally. One coat is usually sufficient, but, two coats are desirable if rotting conditions are severe. Wait six hours before applying second coat. Allow 48 hours to dry before painted.

Dip method: Immerse wood completely for 3-10 minutes per 2 cm of thickness. Dressed lumber: Dip 15-30 minutes per 2 cm of thickness. Treat ends thoroughly. When treating wood, make sure surface is clean and dry. Remove all paint, varnish, wax or other coating. No thinning necessary.

PRECAUTIONS: Avoid breathing vapour. Wear appropriate covering clothing and plastic gloves when applying this product. Wash thoroughly after use and before eating or smoking. Keep food and

animals away from freshly treated material. Poisonous to plants when wet: allow treated material to dry thoroughly before allowing contact with growing plants. May cause skin irritation. Do not apply to fabrics where prolonged skin contact may occur. Do not apply where the preservative may become a component of food, feed or drinking water. Do not apply over Rubberized fabrics.

INFLAMMABLE: KEEP AWAY FROM OPEN FLAMME OR SPARK.

STORAGE AND DISPOSAL: DO NOT REUSE EMPTY CONTAINER, DISPOSE OF CONTAINER IN HOUSEHOLD TRASH. STORE UNUSED PRODUCT OUT OF REACH OF CHILDREN.
