ROSE DUST IS A GENERAL FLOWER DUST FOR THE CONTROL OF LEAF SPOT, BLACK SPOT, PETAL BLIGHT, RUST, POWDERY MILDEW, ROSE APHIDS, THRIPS, CERTAIN CATERPILLARS, AND LEAFROLLERS ON ROSES AND OTHER FLOWERS.

## DIRECTIONS FOR USE:

PLANT DISEASE: Start a regular preventative program as soon as foliage appears. To control black spot, leaf spot, petal blight, powdery mildew or rust on roses, apply at 7 - 10 day intervals during the growing season. Treat weekly during moderate infections, or twice weekly during severe infections caused by continuous summer rain or high humidity.

INSECTS: Treat thoroughly when insect damage first appears. Repeat as necessary. Controls rose leaf beetles, leaf rollers, certain caterpillars, flea beetles, aphids, thrips, white flies, leaf hoppers and lace bugs. For best results, dust in the early morning or late evening when the temperature is low and the air is still. Treat the upper and lower surfaces of all leaves.

LIMITATIONS: Do not use within two weeks of an oil spray treatment. Do not treat during periods of excessively high temperatures (above 30EC) as damage to foliage may occur.

Disease control on roses should be preventive, so treat before any damage appears and follow a regular program.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhaling the dust. May cause irritation of nose, throat and skin. Avoid contact with eyes, skin or clothing. Do not store with feed or foodstuffs.

FIRST AID: In case of contact, flush with plenty of water. If in eyes, get medical attention.

STORAGE: Keep product in original container. Store in a cool, dry place away from food.

DISPOSAL: Do not re-use container. Wrap container and discard in household garbage.
