This wood preservative is a water-repellent, fungicidal coating used to seal the pores of wood surfaces exposed to all weather conditions and prevent the formation of parasitic fungi. It has a clear mat finish with a greenish tinge. Can be covered over with paint thirty (30) days after application. Can be applied on all new or previously weatherproofed wood surfaces. Can be used on pressboard panelling, plywood, casings. Ideal for porch, patio floors and walls.

USE LIMITATIONS: For exterior, above ground use only. Not for use in dwellings. Do not apply where preservative may become a component of food, feed or drinking water. Do not apply to wood or fabrics where prolonged skin contact may occur. Do not use on rubber lined fabric. Will not bleed through if painted over except when white or pastel shades are used.

DIRECTIONS: Make sure the surface to be treated is dry and clean. Remove all paint, varnish, wax or any other coating that could impede penetration. Apply a minimum of two generous coats by brush only. Do not spray or dip. Stir frequently during application. Allow to dry thoroughly before painting or recoating. Do not apply on surfaces which are hot or directly

exposed to the sun. The temperature of the ambient air, product and surfaces to be treated must not be below 10'C.

Drying time: Dry to the touch after 4 hours.

Coverage: 1 litre covers about 8 m2, according to the porosity of the surface. Use as supplied - do not dilute. May be used on greenhouse and garden timbers in close contact with non-food producing plants only. Carrier solvent must be allowed to dry before introducing plants to prevent phytotoxicity.

PRECAUTIONS: Avoid breathing vapours. Harmful or fatal if swallowed or inhaled. Keep away from open flame or spark. Use only under well ventilated conditions. Keep out of reach of children. May cause skin irritation. Avoid skin contact. Wear rubber or plastic gloves and avoid exposure to bare skin by wearing appropriate covering clothing when applying this product. Harmful to plants when wet. Wash thoroughly after use with soap and water and before eating or smoking. Keep container closed when not in use. Do not contaminate bodies of water; toxic to fish.

FIRST AID: Contains mineral spirits. If swallowed do not induce vomiting. Call physician or poison control centre immediately. If splashed in eyes flush with water for 15 minutes. If on skin wash with vegetable oil or hand degreaser, then soap and water.

TOXICOLOGICAL INFORMATION: Contains petroleum distillate and copper naphthenate. Treat as for ingestion of kerosene.

STORAGE & DISPOSAL: Store unused preservative in a cool dry place out of reach of children. Do not reuse empty container. Do not store in areas subject to excessive heat.
