RETAIN POUCH CARTON FOR USE AND DISPOSAL DIRECTIONS.

Used as directed, STOCKAID (R) EAR TAGS will provide season-long control of horn flies and will reduce populations of face flies. Significant production gains can be achieved when horn flies are controlled. Control of face flies may reduce pinkeye infections.

DIRECTIONS:

(a) The entire herd must be tagged to control flies as claimed.

- (b) Rate to use:
 - Horn Flies - tag 1 ear
 - Face Flies - tag both ears
- (c) For maximum benefit, apply early each spring before flies emerge. Delaying application until fly populations have built up may result in some loss of weight gain or pink eye control.
- (d) Remove tags before slaughter.
- (e) Dip pliers with stud into a disinfectant in between tagging of each animal.

APPLICATION PROCEDURE:

STOCKAID EAR TAGS can be conveniently applied with the ALLFLEX TAGGING SYSTEM (TM). Place tag and stud in applicator. Attach tag in the centre of the ear. Make sure the shaft of the male tag does not penetrate a rib or blood vessel.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes, skin or mouth. Wear chemical resistant gloves during application and wash thoroughly after tagging is completed. Store unused tags in original box away from heat.

FIRST AID:

If skin irritation occurs, wash immediately with soap and water. If eye irritation occurs, flush eyes continuously with clear water for 15 minutes. If swallowed, do not induce vomiting. Contact physician immediately, taking STOCKAID EAR TAG carton.

TOXICOLOGICAL INFORMATION:

The treatment should be primarily symptomatic and supportive.

The insecticide in STOCKAID EAR TAGS is highly toxic to fish. Dispose of pouch and used tags according to municipal and provincial regulations. Do not dispose of used tags near a source of water.
