DIRECTIONS FOR USE:

A heavy duty commercial formula insecticide for use in hospitals, restaurants, food plants, supermarkets, motels, hotels, utilities; may also be used in homes when applied by professional Pest Control Technicians.

SPACE SPRAY:

Flying insects: Flies, mosquitoes, gnats, wasps, small flying moths, fruit flies. Close all windows and doors and direct fog upward at a rate of 1-3 seconds per 30 cu. m. Disperse in all location. Keep area closed for 15 minutes. Ventilate before re-entering. Mud dauber and wasps nests: Spray mist directly on insects and their nests.

CONTACT SPRAY:

Grain weevils, flour beetles, saw-toothed grain beetle. chocolate moths, indian meal moth, carpet beetles, drug store beetles in exposed adult and larvaestages: Contact as many insects as possible when treating infested areas such as cracks, crevices, stored products, machinery and dark secluded areas. For carpet beetles, spot treat infested areas of carpet after testing a small inconspicuous area of carpet for colourfastness, localized areas of floors, baseboards and into cracks and under carpets where these pests may be found. Spray 10-20 seconds per 100 sq. m of floor space. Repeat treatment weekly or as insects appear.

FLEAS: Close windows and doors, hold aerosol 1 m above floor and direct fog toward floor and lower walls at rate of 10 seconds per 10 sq. m. Make sure that all floor, sofa and chair surfaces and animal quarters are contacted. Repeat treatment after 7 days.

Cockroaches, spiders, ants, silverfish, crickets: Hold aerosol close to cracks and mist directly into them contacting as many insects as possible. Apply freely in all possible hiding places and behind baseboards, sinks, cabinets, coffee makers, meter boxes, manholes. Repeat all treatments as necessary. Insects must be contacted by insecticide to be killed.

PRECAUTIONARY STATEMENTS:

Do not remain in treated areas. Ensure proper ventilation after sealed areas have been treated. Do not use on food. Keep spray at least 1 m from fabrics to avoid staining. Remove pets, birds and cover fish aquariums before spraying. KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 50 °C may cause bursting. Never throw container into fire or incinerator.

DISPOSAL:

When container is empty, press valve to release all pressure. Dispose of empty container in accordance with provincial requirements.

In meat and food processing plants and food serving establishments, treat only when plant is not in operation. Remove or cover all food packaging materials and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before re-use. Do not use in rooms where milk is processed, handled, or stored. Do not store or spray near open flame or stove.

Avoid inhalation and skin contact. Do not use in nurseries or rooms where infants, ill or aged persons are confined.

FIRST AID INSTRUCTIONS: Flush contaminated eyes with plenty of water and get medical attention. If on skin flush with clean water. If irritation persists, obtain medical attention. Wash contaminated clothing before re-use.
