**DIRECTIONS:** Separate bait stations from the plastic frame. Peel off tape on bottom of bait and secure to surface. Avoid wallpaper or painted surfaces that may be damaged when replacing baits. Place baits wherever ants are seen: by ant trails or hills, at household entry points, or wherever ants are numerous. Do not place directly over food preparation surfaces or in food storage cupboards.

**DISPOSAL:** Wrap container and place in garbage.

**PRECAUTIONS:** Place bait stations in areas inaccessible to children and pets. Do not remove bait from station.
