Do not ship or store with food, feeds, drugs or clothing.

DIRECTIONS FOR USE

Turf and Lawns: Make no more than 2 applications per season. White grubs, European chafer larvae, Japanese beetle larvae. Spray area to give thorough coverage and water into turf. Use 200 mL concentrate/10 L water/100 m2. Apply when grubs are small and feeding near soil surface, usually in late July or August.

Ants, chinch bugs, sod webworms and mosquitoes. Spray ant nests and surrounding areas. Repeat once if ants return. For chinch bugs and sod webworms apply when insects first appear. Apply as a coarse low pressure spray. Lawn should be moist at time of application. Use 100 mL concentrate/10 L water/100 m2. Keep off lawn until spray has dried. For sod webworms delay watering or mowing for 12 to 24 hours after treatment.

Crane fly larvae (leatherjackets). Use 96 to 120 mL concentrate 100 m2. Apply as a drenching spray in water in the late fall after the flight of adult crane flies has ceased for the year.

Ornamental Shrubs and Bushes: Make no more than 2 applications per season. Ants, crickets, earwigs, sowbugs, spiders, cutworms, white grubs, European chafer larvae and Japanese beetle larvae. Spray soil around plants to give good coverage. Use 100 mL concentrate/10 L water/100 m2.

For the following foliar insect pests: aphids, ash and lilac borers, mealybugs, mites, scales, spittlebugs, thrips and whiteflies apply 10 mL concentrate/L water and spray to give uniform coverage. Do not use on roses, azaleas, camellias, poinsettias, geraniums, oxalis, coleus or variegated ivy.

Native Elm Bark Beetle: To prevent the adult beetle from overwintering in uninfected trees and to reduce beetle populations in disease free areas, apply as a 0.48% to 0.5% mixture of chlorpyrifos in water to the bottom 2.5 m of the trunk. Wet the trunk thoroughly but do not spray to run off. Care should be taken to apply the spray right to the base of the root flare. Make only one application per season.

The following spray dilution chart indicates the proper proportion of concentrate to water to give a 0.48% to 0.5% chlorpyrifos solution:

5 L 250 mL 10 L 500 mL

For best results the use of Dursban Home & Garden Spray Concentrate insecticide should be incorporated into a total integrated Dutch elm disease control program to include both chemical and necessary sanitation techniques.

Gardens: When damage from cutworms is evident, apply spray to give uniform coverage. Use on broccoli, Brussels sprouts, cabbage, Chinese cabbage, cauliflower, carrots, celery, cucumber, green pepper, onion, potato, strawberries, sweet corn and tomato. (See table below for days to wait between application and harvest). For carrots and onions use 60 mL concentrate per 5 L water and apply 3 L mixture per 100 m of row. For strawberries use 60 mL concentrate in 10 L of water per 100 m2 and apply once between June 1 and June 15.

For control of potato flea beetle and tarnished plant bug on potato, apply 40 mL concentrate in 10 L of water per 100 m2. Apply weekly as needed. Do not make more than 9 applications during one season.

For the other crops listed use 30 mL concentrate per 5 L water and apply 3 L mixture per 100 m of row. Do not use on green bunching onions. Make no more than 1 application per season.

Insect Pests Indoors:

Cockroaches, ants, carpet beetles, crickets, earwigs, firebrats, fleas, silverfish, sowbugs, spiders, Brown Dog ticks. Apply as a spot treatment to surfaces, along baseboards and behind fixtures where these pests are a problem. For fleas and ticks, apply spray to pet beds and resting quarters, nearby cracks and crevices. Cover or remove all food before treatment. Replace bedding after treatment. DO NOT TREAT PETS. Do not allow spray to contact food, food preparing surfaces, utensils or drinking water. Wash contaminated food preparing surfaces and utensils with soap and water before using. Apply as a coarse spray. Use 25 mL concentrate / L water for cockroaches, ants, crickets, firebrats, silverfish, spiders and sowbugs. Use 50 mL concentrate / L water for fleas, ticks and carpet beetles. Repeat as needed but no more than once every two months.

WARNING
