Notification Change

Powdery mildew: on roses, chrysanthemums, grapes, strawberries, currants, gooseberries, beans, dahlias and many others. Concord grapes and other sulphur-shy varieties of plants may be sensitive to this product. Spray at first sign of disease and repeat at 10-14 day intervals.

Black Spot: on roses. Spray every 7-10 days to ensure thorough coverage of new foliage and stems.

Rust: on currants, gooseberries, beans and ornamentals. Spray at first sign of disease and repeat at 10-14 day intervals as necessary.

Preharvest Interval: Apply up to 1 day before harvest for all crops except wine grapes, which require a 21 day interval.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not apply within 30 days of an oil treatment or at high temperatures. Do not apply to Boston Fern. Avoid contamination of food and feed. Do not heat or store at high temperatures.

FIRST AID:

If on skin or in eyes, flush affected area thoroughly with water. If swallowed obtain medical attention immediately or contact a Poison Control Centre IMMEDIATELY. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.
