## USE DIRECTIONS

A proven "one-step" cleaner - disinfectant - sanitizer - fungicide - mildewstat - virucide in the presence of moderate amounts of organic soil. Apply to walls, floors and other hard, non-porous surfaces such as tables, chairs, countertops, sinks and bedframes, with a cloth, mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when used solution becomes visibly dirty.

**HOSPITAL SANITIZER:** Use 1:165 or 6 mL per Litre of water. Effective against a broad spectrum of gram negative and gram positive organisms as presented by: *Pseudomonas aeruginosa*, *Staphylococcus aureus*, *Salmonella choleraesuis*, *Escherichia coli*, *Serratia marcescens*, *Klebsiella pneumoniae*, *Enterobacter aerogenes*, *Salmonella schottmuelleri*, *Streptococcus faecalis*, *Shigella dysenteriae*, *Brevibacterium ammoniagenes*.

**DISINFECTION:** To disinfect hard, non-porous surfaces, treated surfaces must remain wet for 10 minutes.
