- Mix 250 mL Ghost Master Bathroom per **2** bucket (4 Litres) of warm water.

Use on hard non-porous surfaces.

- Apply full strength product on the soil and let stand for 10 minutes before wiping.
- For heavily soiled areas, clean as per General Cleaning.
Then follow disinfectant directions.
