DIRECTIONS

Remove protective cap. Hold dispenser upright with valve opening away from face. Push button completely down to release stream.

FOR CONTROL OF WASPS AND HORNETS:

Apply to the nest in the early morning or late evening when these pests are at rest. Aim valve opening at nest and depress button, soaking nest with the spray. Repeat as necessary. Avoid wetting vegetation with this spray as it will be damaged. Do not use as a space spray. Spray infested areas such as under porches, eaves, doors, and window frames.

OTHER USES - OUTDOORS ONLY:

For control of ants, clover mites, crickets, earwigs, millipedes, sow bugs and brown dog ticks: Spray infested areas thoroughly, including outside surfaces of screen frames, doors, window frames, foundations, patios, and other places where insects may enter to harbour. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation. Do not use as a space spray. Do not use indoors.
