FRUIT: FOR USE ON Apple, Apricot, Cherry, Grape, Peach, Pear, Plum, Strawberry; to control aphids, caterpillars, flea beetles, fruit flies, leafhoppers, leafminers, mealybugs, mites, scales, thrips.

VEGETABLES: FOR USE ON Bean, Beet, Broccoli, Cabbage, Carrot, Cauliflower, Celery, Cucumber, Lettuce, Onion, Parsnip, Pepper, Potato, Radish, Spinach, Tomato; to control aphids, carrot rust flies, caterpillars, Colorado potato beetles, flea beetles, leafhoppers, leafminers, mites, root maggots, thrips.

FLOWERS AND ORNAMENTALS: FOR USE ON Azalea, Birch, Boxwood, Carnation, Cedar, Crabapple, Fir, Ivy, Juniper, Mum, Oak, Pine, Rose, Spruce, Yew; to control aphids, caterpillars, flea beetles, leafhoppers, leafminers, mealybugs, mites, pine shoot moths, rose chafer, scales, thrips.

DIRECTIONS FOR USE: FRUITS, VEGETABLES AND ORNAMENTALS.

Mix 60 mL (4 tablespoonfuls) in 10 litres of water. Spray when insects are noticed and repeat as needed; for Carrot Rust Fly Maggot and all Fruit Fly Maggots, spray every week between June 20th and July 31st. Also, consult Provincial Home Garden Guide. Do not apply to a food crop within 10 days of harvest except for the following: Tomato – 1 day; Broccoli, Cauliflower, Pepper, Strawberry – 5 days; Beans, Cabbage, Cucumber – 7 days; Apple, Pear, Beet, Potato – 14 days; Grape and Peach – 20 days. For cutworms in all vegetables, apply 60 mL (4 tablespoonfuls) in 10 litres of water on 9 m²; immediately BEFORE planting and rake into soil 8 to 10 cm deep.

LAWN INSECTS:

SPOT APPLICATION ONLY:

For chinch bugs – mix 4.2 to 8.4 mL in 1 L of water. Apply 1 L per m². Use for spot treatment only in areas of infestation. Water lightly before and after application.

For ants and sod webworms (lawn moths) – mix 3.5 to 7.0 mL in 1 L of water. Apply 1 L per m² only in areas of infestation.

For earwigs – mix 52 mL in 1 L of water. Use for spot treatment only in areas of infestation.

BROADCAST APPLICATION:

For suppression of White Grubs (eg. Larvae of European chafer and Japanese beetle) – mix 42.5 mL in 10L of water to cover 10 m². Apply when sampling indicates that white grub larvae are actively feeding. Thoroughly water into the lawn after treatment. Do not use in areas where the thatch is greater than 3 cm thick.
