WESTOSAN is an odourless cleaner-disinfectant recommended for use in food processing plants, bakeries, restaurants, etc. It eliminates odours by destroying odour-causing bacteria.

DIRECTIONS FOR USE:

FLOORS & WALLS - To clean and disinfect floors and washable walls, use 15 mL of WESTOSAN per litre of water. Wet surfaces thoroughly and clean in the usual manner.

FOOD HANDLING EQUIPMENT, CUTTING BOARDS, REFRIGERATORS, ETC.- Use 15 to 27 mL of WESTOSAN per litre of water. Wash thoroughly and, in compliance with health department codes, rinse with potable water.

TOILET FACILITIES - Use 15 mL of WESTOSAN per litre of water to clean and disinfect toilet seats, urinals, sinks and fixtures. Wet surfaces thoroughly and scrub in usual manner.

NOTE - Do not mix WESTOSAN with soap or other cleaning agents.

Rinse empty container thoroughly with water and discard it.
