NATIONAL CHEMSEARCH DOUBLE-QUICK is a highly concentrated contact insecticide, formulated with pyrethrins and a synergist in a highly refined mineral oil base. NATIONAL CHEMSEARCH DOUBLE-QUICK, when used as directed is recommended for use in bakeries, groceries, grain mills, elevators, bottling plants, restaurants, and other industries that require a relatively non-staining, low order of toxicity insecticide. For use in food processing plants, use only when plant is not in operation. Remove or cover all food, packaging materials and utensils before application. After application wash all surfaces that may contact food and rinse thoroughly with potable water before re-use for food processing.

KEEP FROM FREEZING:

If this product is stored in cold or freezing weather it may separate or thicken. This will not harm the performance. Before using, warm to room temperature and stir thoroughly.

WEEVILS & MOTHS INFESTING STORED FOOD PRODUCTS:

Clean areas to be sprayed, especially cracks, crevices and around machinery. To spray food storage ares, remove food products from shelves and racks. Spray these areas thoroughly with NATIONAL CHEMSEARCH DOUBLE-QUICK and replace food products. For packaged food, spray in such a manner that a light mist will fall upon the packages. For food products in sacks, spray thoroughly between and around the sacks paying particular attention to all cracks, cervices, walls, and any other places that might offer shelter to the weevils. Contact as many weevils as possible. After all the local areas of storage have been sprayed, close all windows and doors. Thoroughly fog the entire storage areas being extremely careful that all open food products are covered. After 10 to 20 minutes, sweep up and destroy the fallen insects. Repeat sprayings at least once a week or when reinfestation becomes evident.

TREAT UNLOADING, HANDLING AND PROCESSING AREAS:

Spray the conveying, processing and handling equipment such as the inside of reel conveyors, sifter, hoppers, and proffers as well as around the base of heavy machinery and equipment. After 10 to 20 minutes remove dead insects and run equipment to aerate before beginning operations.

FOR COCKROACHES, SILVERFISH AND CERTAIN OTHER CRAWLING INSECTS:

Direct spray in such a manner as to penetrate all cracks, crevices, and other hiding places. Thoroughly fog around shelves, under sinks, refrigeration equipment, dishwashing machines, and bottle washers. Treat all returned bottle cartons and cases. Contact as many insects as possible. For badly infested areas, spray daily. During the summer months, spraying twice a week is advisable.

FOR FLIES AND MOSQUITOES:

Close all doors and windows before spraying. Direct spray towards the ceiling and continue spraying until the area is thoroughly fogged. After 10 to 20 minutes, sweep up and destroy all fallen insects. Repeat spraying as often as necessary.

PRECAUTIONS IN USE:

Avoid breathing of spray mist and ventilate sprayed areas after application. Avoid contamination of food, utensils and food preparation areas. Combustible mixture. Do not apply near open flame.

FIRST AID:

In case of contact with skin, wash thoroughly with soap and water. In case of eye contact, rinse with plenty of water for 15 minutes, get medical attention.
