The Reflecting 2 in 1 (R) Plus Collar provides an added dimension of nighttime safety for the pet and its owner. The collar will reflect when light shines directly on the reflecting strip. To demonstrate this effect, sit in your parked car with the headlights on and have someone walk the dog into the headlight beam. The reflecting strip will shine bright white from car or truck headlights, making the pet visible to the driver for up to 135 m.

The Reflecting 2 in 1 (R) Plus Collar will begin immediately to kill fleas and nonengorged ticks, including Rocky Mountain Wood Tick, carrier of Rocky Mountain Spotted Fever. For continuous protection against fleas under light pest pressures replace the collar every four months, for ticks every five months. Under conditions where dogs are exposed to severe flea or tick infestations it may be necessary to replace the collar more frequently. The flea collar may be worn with a regular collar. Wetting will not impair the collar's effectiveness or pet's protection. However, the collar should be removed if the dog is bathed with soap or detergent.

**DIRECTIONS:** Remove the collar from the package, unroll and STRETCH to activate. This releases the active ingredient at time of use and assures full activity. REMOVE paper cover from reflecting strip. Place the flea collar around the dog's neck, making sure that reflecting strip is on outside of collar. Allow a spacing of 2 fingers between collar and neck and buckle in place. Leave 5 to 8 cm on the collar for extra adjustment. Cut off any excess length and dispose of it in the garbage.

**CAUTION:** Do not allow children to play with collar. Do not unroll collar until ready to use. This collar is intended for use only as an insecticide generator dog collar. Do not use on puppies less than three months old. Any irritation usually indicates that the collar has been affixed too tightly. If irritation occurs, loosen the collar. If irritation continues, remove the collar from the animal and consult your Veterinarian. Dispose of expired collars, any excess collar and pouch with garbage out of reach of children. Wash hands with soap and water after handling collar.
