LEMON TREE is a cleaner, disinfectant and sanitizer designed for institutional use such as Hospitals, Nursing Homes and Institutions where housekeeping will be of prime importance in controlling the hazard of cross infection. LEMON TREE is very effective for controlling odors caused by the growth of bacteria, mold, mildew and fungi. It is recommended for use on floors, walls, sinktops, garbage pails, telephones, rest rooms, bed pans and operating rooms.

DISINFECTION: Use 1 part per 49 parts water (900 p.p.m. active). Apply with a cloth or mop. Allow surface to remain wet for 10 minutes, then remove excess liquid. Prepare a fresh solution for each use. Rinse and allow to dry. DO NOT MIX WITH OTHER CLEANERS. Rinse empty container with water before discarding.

SANITATION: If used for sanitation of food equipment or food contact items, limit the level of active sanitizer to 200 p.p.m. (1 part per 220 parts water). Rinse with potable water.

TOXICOLOGY: Probably mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
