DIRECTIONS FOR USE: Apply C-I-L® BUG-X® using the hose-end applicator attached. It will dilute this concentrated insecticide for direct spraying of fruits, vegetables and ornamentals.

1. Read the complete label for application instructions and precautions. 2. Shake container thoroughly before attaching to garden hose. 3. Turn water supply on at the source. Water pressure will build in hose since the sprayer is already in the "OFF" position. 4. To apply product, bend safety tab and turn the control valve clockwise to the "ON" position. 5. For best results, hold sprayer and bottle level. A light spraying to wet the foliage is recommended, but not to the point of run-off. 6. When spraying is complete, turn the control valve counterclockwise so that the valve indicator arrow is pointing to the "WATER" position on the sprayer. Flush with water to clean sprayer head, then turn the control valve to "OFF" position. Turn water off. Disconnect hose from applicator and store product in original container. NOTE: "WATER" position is to be used only for cleaning sprayer head.

GENERAL GARDEN USE: Spray when insects are noticed and repeat as needed; for carrot rust fly maggot and all fruit fly maggots, spray weekly between June 20th and July 31st. A light spraying to wet the foliage is recommended, but not to the point of run-off. Do not apply to a food crop within 10 days of harvest except for the following: tomato -1 day; cauliflower, broccoli, pepper, strawberry -5 days; beans, cabbage, cucumber -7 days; apple, pear, beet, potato -14 days; grape and peach -20 days.

CAUTION: Rate of delivery of product will vary depending on water pressure, location, time-of-day, length and diameter of hose, etc. Complete contents of 1.25 L container can be sprayed in approximately 3 to 6 minutes.

FRUIT: FOR USE ON Apple, Apricot, Cherry, Grape, Peach, Pear, Plum, Strawberry; to control aphids, caterpillars, flea beetles, fruit flies, leafhoppers, leafminers, mealybugs, mites, scales, and thrips.

VEGETABLES: FOR USE ON Bean, Beet, Broccoli, Cabbage, Carrot, Cauliflower, Celery, Cucumber, Lettuce, Onion, Parsnip, Pepper, Potato, Radish, Spinach, Tomato; to control aphids, carrot rust flies, caterpillars, Colorado potato beetles, flea beetles, leafhoppers, leafminers, mites, root maggots, thrips.

CUTWORMS IN VEGETABLES: Apply 250 mL evenly over 19 m² (200 sq. ft.) of garden immediately before planting and rake into top 8 to 10 cm (3-4") of soil.

FLOWERS AND ORNAMENTALS: FOR USE ON Azalea, Birch, Boxwood, Carnation, Cedar, Crabapple, Fir, Ivy, Juniper, Mum, Oak, Pine, Rose, Spruce, Yew; to control aphids, caterpillars, flea beetles, leafhoppers, leafminers, mealybugs, mites, pine shoot moths, rose chafer, scales, and thrips.

LAWN INSECTS – SPOT TREATMENT ONLY: For chinch bugs – Water lightly before and after application. Apply 8 to 16 mL per m². Use for spot treatment only in areas of infestation. **For ants and sod webworms (lawn moths)** – Apply 6.8 to 13.6 mL per m² only in areas of infestation. **For earwigs** – Use for spot treatment only in areas of infestation.

LAWN INSECTS – BROADCAST APPLICATION: For suppression of White Grubs (eg. larvae of European chafer and Japanese beetle) – Apply 800 mL per 100 m² when sampling indicates that white grub larvae are actively feeding in late July or August. Thoroughly water into the lawn after treatment. Do not use in areas where the thatch is greater than 3 cm thick.
