DIRECTIONS FOR USE: Dosage depends upon the severity of microbiological contamination and concentration of corrosive agents present. For extended applications, dosages should be varied dependent on microbiological counts. For details, consult your Nalco technical representative. Usual dosage ranges are as follows: oil production, salt water disposal and water flooding, 15 to 50 mg/L continuous, 75 to 200 mg/L batch. Recirculating systems, 10 to 150 mg/L.

Do not use in potable water supply.

Do not mix as a concentrate in combination with strong oxidizing agents.

PRECAUTIONS: Wear suitable face and hand protection when handling. Avoid getting in eyes or on skin. Avoid prolonged breathing of vapours. Do not take internally. Keep away from open flame or excessive heat. Remove contaminated clothing and laundry before reuse. Avoid contamination of food.
