VAPONA* LIVESTOCK SPRAY is a specially prepared, ready-to-use insecticide suitable for use in any conventional hand, microsol or automatic spray equipment.

When applied to dairy cattle, beef cattle and horses it reduces the populations of such annoying pests as stable flies, horn flies, and house flies.

Dairy and Beef Cattle:

Spray flanks, legs, brisket, head and neck on each side of the animal, beginning at the tail and moving forward. Apply sufficient spray to dampen hair, usually about 30 to 60 mL depending on the size of the animal. One or two applications per day may be necessary during period of high fly population and persistent annoyance. Do not overspray dairy cattle.

Horses:

Spray lightly paying particular attention to areas where flies are congregating.
