How Mice Hear and How They Can Be Repelled

Since the beginning of his existence, man has utilized sound to repel other living things in order to protect himself, his family

and his environment.

In this age of high technology, with the invention of the transducer, we are now able to both detect and produce sounds that extend beyond the range of human hearing.

Ultrasonics - or ultrasound - are terms used to describe sounds above the limits of human hearing, or above 20,000 Hz. Rodents have well developed auditory (hearing) systems.

ABOUT WEITECH 800

Weitech 800 emits intense sound waves which penetrates the nervous systems of mice and drives them away. Because of the intensity and complexity of the sounds, they usually will not be able to build up an immunity to them.

Weitech 800 will have a maximum range of about 74 square meters (800 square feet). However, ultrasonic sounds may be absorbed by soft materials such as upholstered furniture, draperies and carpets. Therefore, the more of these items, the less distance Weitech 800 sounds will carry.

Power consumption is approximately 18 milliamps or about 15 cents to 25 cents per month when operated continuously, depending upon the cost of electricity in your area. (U.L. and C.U.L. listed)

DIRECTIONS FOR USE:

Simply plug into any standard 110-volt electrical wall outlet. An L.E.D. light will illuminate whenever the unit is operating. The unit functions automatically and continuously as long as the unit is plugged in. Do not use in the presence of rodent pets such as hamsters, gerbils, ferrets, guinea pigs, etc.

The unit should be positioned to take advantage of hard surfaces (walls, windows, mirrors) so that the sounds can "bounce off" or ricochet. This creates an echo effect that compounds the sounds and creates more disruption.

Operate the unit 24 hours a day for at least 30 days. Then, for best results, use the Weitech 800 continuously, occasionally moving the unit to a different wall outlet location, or placing it in a different room.

ABOUT MICE

Mice are creatures of habit. They follow consistent routines, living in social groups or communities with others of their kind. They prefer to do their prowling and eating at night, but if

hungry enough, they will venture out in daylight to find food. They seldom travel more than 45 meters (150 feet) from their nest.

Mice have adapted perfectly to living with man. Throughout history, they have been responsible for the transmission of diseases and enormous food losses. All rodents have very well developed hearing that is sensitive to both sonic and ultrasonic noises.
