DIRECTIONS

FOR CONTROL OF GRAIN INSECTS

CHOCOLATE MOTH, ANGOUMIS GRAIN MOTH, INDIAN MEAL MOTH, MEDITERRANEAN FLOUR MOTH, FLOUR BEETLES, FLAT GRAIN BEETLES, CONFUSED FLOUR BEETLE, SAW TOOTHED GRAIN BEETLE, CADELLES, FLOUR WEEVILS, RICE WEEVILS, GRANARY WEEVILS. To kill the exposed stages of these pests, mix 1 litre PYRATEX 101E with 4 litres water and spray thoroughly walls, beams, ceilings, pipes, undersides of pallets, interiors of storage bins, chutes, elevator shafts, etc., so as to hit as many insects as possible and to effect a thorough coverage of all surfaces. Use at the rate of 5 litres spray solution per 100 square metres of surface. Pay particular attention to all cracks, crevices, and other hiding or nesting places. Hold container upright while spraying. During warm weather weekly application should be made. Treat only empty storage bins.

FOR CONTROL OF ENVIRONMENTAL PESTS: ants, cockroaches, silverfish, spiders, fleas, crickets: Mix 1 litre PYRATEX 101E

with 4 litres water and apply at the rate of 1-2 Litres per 100 square metres to infested areas around refrigerators, sinks, undersides of tabletops and shelving, all cracks, crevices, baseboards, moulding and other hiding places or nesting places. Apply also around all pipe openings through walls, floors and ceilings and open cracks between tiles. Repeat treatment as necessary.

CAUTION: Water based sprays may stain finished surfaces.

NOTE: This product is not for use as a broadcast application.

FOR CONTROL OF FLYING INSECTS: FLIES, MOSQUITOES, BITING MIDGES, WASPS, MOTHS, SMALL FLYING INSECTS: PYRATEX 101E mixed with water may be used as both a space and contact spray. Mix 1 Litre of PYRATEX 101E with 24 Litres of water, and use at a rate of 30-40 mL per 100 cubic metres. Direct the spray towards the ceiling trying to contact as many insects as possible. Fill the room or storage areas with mist and leave closed for 10-15 minutes. Repeat treatment as necessary. Ventilate building before reoccupying. Following ventilation clean up dead insects.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid inhaling spray mist. contact with skin, eyes, and clothing. Wash after use. remain in treated areas.
