DIRECTIONS FOR USE: Never apply when air temperature is above 21'C.

TURF: For control of Pink snow mold and Grey snow mold--mix 60 mL of PMA-10 with 15 L of water to cover 100 m2 of turf.

Apply in late fall after the danger of heavy rain is past, but before permanent snow cover. Repeat during mild winter thaw when the turf is exposed. To control and prevent the spread of disease under cool wet conditions in the spring, make an additional application after the spring thaw. For control of Brown patch, Copper spot, Curvularia, Dollar spot, Helminthosporium, and Pink patch--mix 60 mL of PMA-10 with 15 L of water to cover 100 m2 of turf. As a preventative treatment, apply at intervals of 10 to 14 days from early spring through the summer. As a curative treatment, apply at 7 to 10 day intervals until the disease is controlled.

On golf greens and tees--cut the grass to 0.6-1.2 cm high and use 30 mL of PMA-10 with 15 L of water to cover 100 m2. This treatment will also suppress the growth of mycelium (or toadstool) caused by fairy ring.

LIMITATIONS: Do not apply on Merion Bluegrass. Do not use clippings from treated areas for feed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN and animals. Store container tightly closed in a dry ventilated place away from feeds and foodstuffs. Do not store in metal containers as this solution is corrosive to metal. Do not use aluminum equipment. Wear natural rubber gloves while handling the concentrate. Do not breathe the spray mist. Poisonous if swallowed, inhaled, or absorbed through the skin. Skin contact can result in delayed chemical burns. Avoid contact with skin, eyes, and clothing. Wash hands thoroughly after handling and before eating, drinking or smoking. Remove contaminated clothing and wash before re-use. Keep children, animals, and poultry away from the sprayed area. Do not contaminate neighbouring crops, ponds, lakes or streams.

FIRST AID: If on skin: Remove all contaminated clothing. Wash skin and hair thoroughly with soap and water. Wash clothing before re-use. If irritation persists, get medical attention.

If in Eyes: Flush with running water for at least 15 minutes while holding eyelids open to help flush out material. Get medical attention.

Ingestion: Drink 1-2 glasses of water and induce vomiting. Never induce vomiting or give anything by mouth to an unconscious person. Keep head lower than chest to avoid aspiration into lungs. Call physician immediately.

Inhalation: Remove to fresh air. If breathing is difficult, administer oxygen; if breathing stops administer artificial respiration. Get medical attention immediately.
