There is no guaranteed method of responding to a bear encounter, each encounter is unique. Strict attention to the advice of wildlife professionals on safety is advised. Severe irritation to eyes, nose and skin can occur. Use outside only. Persons with respiratory problems or wearing contact lenses should not use this product. When travelling, DO NOT STORE IN PASSENGER COMPARTMENT. Contact air carriers for regulations concerning air transport. Be careful not to puncture canister and do not expose to temperatures above 50°C.
