DIRECTIONS FOR USE

Completely water soluble, mild on hands, and excellent deodorizing activity by eliminating odour causing bacteria. For walls, floors, tables, refrigerators, stoves, sinks, bathroom fixtures, food utensils, and garbage cans, in homes, public places and hospitals, processing plants, including meat and fish, animal and bird cages, kennels, barns, etc.

- A. To clean and sanitize, use a solution of 3 mL FASSIL SAN-DET per litre of water.
- B. To clean, disinfect and deodorize, use 6 mL FASSIL SAN-DET per litre of water.
